## 1. Brief Synopsis:

- (a) The above mentioned matter was filed on 17.2.2020 and was registered as W.P. (C) No. 406/2020 on 28.2.2020. Vide the said Writ Petition; the Petitioners have challenged the constitutional validity of the Transgender Persons (Protection of Rights) Act, 2019 particularly Sections 4, 5, 6, 7, 12(3), 18(a) and 18(d) thereof, being ultra vires of Part III of the Constitution of India, 1950, in particular being in violation of Articles 14, 15, 16, 19 and 21 of the Constitution of India. That the Petitioners had also filed an application for stay praying thereby for ad interim ex parte stay of the effect and operation of the Transgender Persons (Protection of Rights) Act, 2019.
- (b) That this Hon'ble Court in NALSA vs. Union of India, (2014) 5 SCC 438 has held that, a person has the right to identify their gender as male, female or transgender and that the right to self-determine one's gender identity is an integral part of one's right to life, dignity and autonomy in Article 21 of the Constitution. However, Section 4 of the Act mandates that a transgender person shall have a right to be recognized as such, which limits their rights to self-determine one's gender identity and as such is unconstitutional. Section 5 and 6 provides that identity cards shall be issued based on documents, and Section 7 provides for transgender

persons to undergo medical surgery in order to identify with a gender of their choice. These provisions violate the right to self-determine, right to dignity and bodily integrity of transgender persons, besides being contrary to several judgements of this Hon'ble Court. These are also in violation of the internationally recognized Yogkarta Principles.

## 2. Ground for Urgency:

- (a) That the vide news report dated 18.4.2020, the Petitioners have come to know that the Government has prepared the Draft Rules under the Act and has called for comments on the same which is to be submitted by 30.4.2020. - (b) Hence it is most respectfully submitted that unless the matter is listed urgently before the Hon'ble Court, there is every possibility that the Rules shall be notified and the provisions of the Act shall be acted upon which shall have serious adverse impact on the fundamental rights of the Petitioners herein and shall cause grave prejudice to them.
