O R D E R

I.A. No.23882/2020 in Civil Appeal No(s).1867/2006

Having heard learned counsel appearing for the parties at length and upon perusal of the instant application for direction, we are of the view that the interests of justice would be best served if the State Government apprises Hon'ble the Chief Justice of Calcutta High Court, of any material pertaining to the list of Judges on the select list.

Hon'ble the Chief Justice of Calcutta High Court may take an appropriate decision and finalise the list of Judges by 07.03.2020.

After Hon'ble the Chief Justice of Calcutta High Court finalises the list, the appointment of Judges should be notified.

The Registrar General of the Calcutta High Court may file an updated report in a tabular form within a period of two weeks.

Order accordingly.

List the instant application thereafter.
