Note on Behalf of the Election Commission of India

- Vide the captioned Interlocutory Applications, the Applicants have, inter alia, prayed for extension of timelines in the ongoing Special Intensive Revision ("SIR") exercise for filing claims and objections for those individuals whose names are not included in the Draft Electoral Roll.
- 2. According to the records, approximately 99.5% of the electors (out of 7.24 crore) featured in the Draft Electoral Roll for the State of Bihar have already submitted their eligibility documents pertaining to the SIR exercise. The exercise of verification of these documents is currently ongoing, and is scheduled to be completed by 25.09.2025, in accordance with the Schedule provided in the SIR Order dated 24.06.2025.
- 3. In so far as the I.A. filed by Rashtriya Janata Dal ("RJD") is concerned, the assertion that it has filed 36 claims through its Booth Level Agents ("BLAs") is incorrect and misleading. The correct position as per records is that only 10 claims have been

submitted by RJD through its validly appointed BLAs. However, as is admitted in the I.A., all 36 claims have been accepted by the Booth Level Officers ("BLOs") and are being processed [see Para 6.5 read with Annexure A-3, Pp. 35 - 70 of I.A.].

- 4. So far the I.A. filed by Communist Party of India (Marxist-Leninist) ("CPI-ML") is concerned, the Applicant asserts that it has lodged a total of 351 claims and objections, however, the ECI's website reflects that they have filed only 79 claims [see Para 3(a) of I.A.]. These assertions are incorrect and misleading. The correct position is that CPI-ML has submitted 15 claims for inclusion and 103 objections for exclusion as on 31.08.2025. Significantly, even as per their own data annexed to the I.A., only 50 instances are detailed, of which, an overwhelming majority are for exclusion, except entries 24, 27- 29, 32 34, 42 44, 47- 49. Thus, the assertion that their validly appointed BLAs have submitted 351 claims and objections is not substantiated [see Annexure A-1, Pp. 8 10, I.A.].
- 5. In particular, it is submitted that apart from CPI-ML and RJD, none of the other recognized political parties have, either though their office bearers or validly appointed BLAs, assisted any elector out of the approximately 65 lakh whose names are not included in the Draft Electoral Roll to submit Form 6 with Declaration. None of the other recognized political parties have enabled filing of claims or objections in the prescribed format.
- 6. The updated Daily Bulletin of the Election Commission of India ("ECI"), as on 31.08.2025, is appended herewith. The said Bulletin indicates that an overwhelming majority of Forms received from

both political parties and individuals are for exclusion of names which are featured in the Draft Electoral Roll.

- Of the total 128 forms received on the draft rolls from political parties, 103 are for deletion (Form 7) and only 25 are for inclusion (Form 6). This number represents a miniscule fraction of the total number of electors of Bihar.
- Although the individual electors have demonstrated more alertness and proactiveness, they too have submitted only 33,326 forms (Form 6) for inclusion in the draft roll and 2,07,565 forms (Form 7) for deletion.
- With respect to new eligible citizens attaining the age of 18 years or more, a total of 15,32,438 applications for first-time inclusion in the electoral roll have been received. These applications are distinct in nature as they pertain to fresh enrolment and not to claims or objections relating to existing electors.

- 7. As regards the approximately 65 lakh names which are not included in the Draft Electoral Roll on account of death, permanent shifting, or duplication, only 33,326 + 25 = 33,351 claims have been submitted. Post the Order of this Hon'ble court dated 22.08.2025 till 30.08.2025, only 22,723 claims have been filed for inclusion and 1,34,738 objections have been filed for exclusion.
- 8. In so far as extension of timelines for filing claims and objections beyond 01.09.2025 is concerned, the extension of deadline would disrupt the entire schedule for finalisation of Electoral Roll. The timelines have been fixed according to the Rules, and maximum

time of thirty (30) days has been provided for filing claims and objections [see Rule 12, RER 1960].

- 9. Further, the Draft Electoral Roll and ASD list has been widely publicized and the ASD lists have also been shared with political parties on 19/20th July. Additionally, the BLAs were also given the ASD list along with reasons for exclusion. Notably, both the BLOs and BLAs are residents of the village where the booth is located. All electors have easy access to them. Subsequently, the ASD list along with reasons for exclusion was also published on the website of District Electoral Officers and Chief Electoral Officer; posted on social media accounts; posted at Block offices, Panchayat Bhavans, and polling booths across Bihar, as per the Order of this Hon'ble Court dated 14.08.2025. The Order of this Hon'ble Court has been fully complied with by issuing advertisements in all newspapers. Therefore, there has been sufficient availability of time for filing applications for claims or objections or corrections under the prescribed format. As mentioned above, there are more applications for exclusions than for inclusions.
 - 10. The period between 01.09.2025 25.09.2025 is fixed for considering claims and objections, and the same also involves consideration of issuing notices and responses to doubtful cases. Thus, any extension of timelines will lead to disruption of the exercise and finalisation of electoral roll
 - 11. Most importantly, the filing of claims or objections or corrections is not barred after 01.09.2025. These can be submitted even after the deadline. The applications submitted for claims, objections or

corrections after 01.09.2025 will be considered after the electoral roll has been finalised. The process of consideration of claims and objections continues until the last date of nominations, and all inclusions and exclusions are integrated in the final roll.
